#### New CCDBG Act of 2014 Requirements

- Establish health and safety requirements in 10 different topic areas.
- Child care providers must receive pre-service and ongoing training on such topics.
- Conduct criminal background checks for all child care staff members, including staff members who don't care directly for children.
- Certify child care providers will comply with child abuse reporting requirements.
- Conduct pre-licensure and annual unannounced inspections of licensed CCDF providers and annual inspections of license-exempt CCDF providers.
- Establish qualifications and training for licensing inspectors and appropriate inspector-to-provider ratios.
- Have standards for CCDF providers regarding group size limits and appropriate child-to-provider ratios based on the age of children in child care.
- Emergency preparedness planning and statewide disaster plans for child care.





## Unintentional Injury Fatalities & Death Rate (19 years and under)



# Unintentional Injury Rate by Race and Risk






